- · Aid should benefit at least 100 community members





# SPECIAL CAMPAIGNS AND ANNUAL FUND

 Annual Funds are year-long (fiscal) initiatives that support the general operational needs of the Foundation

 Credit is given towards Club Service Awards



#### **CLUB 21**

- Established in 1997 to support organizations that aim to meet 21st century needs, primarily in thea areas of healthcare, education, economic development, and leadership
- Designated Fund
- Individual Members
- Club Level
- District Level
- This type of general donation meets the most pressing needs of Foundation

#### Club 21 Annual Membership

- Supports children and their families affected by disease and disability, and educational healthcare programs in West Africa
- \$21.00 per year qualifies an individual as a Club 21 member
- \$210.00 qualifies an Altrusa Club or District as a Club 21 member
- Individuals receive a one-time Club 21 pin; Districts/Clubs receive a one-time Club 21 medallion.
- Membership renews annually from the date dues are paid, but many clubs collectively renew memberships in April-May.
- Does not count towards Lamplighter contribution progress

# Planned Giving and Annual Club 21 Membership

#### **Planned Giving**

- As the name suggests, planned gifts are donations that are set up now to be donated at a future date.
- Planned giving donations are usually arranged for after a donor has passed away and can also be referred to as legacy giving.
- While legacy gifts are often made as a bequest in a donor's will, they can take other forms as well, including:
- gifts of life insurance,
- charitable annuities,
- charitable remainder trusts, and
- gifts of stocks or securities.
  - All Planned Giving bequests to the Altrusa International Foundation are restricted to the Endowment Fund



- In celebration of the Foundation's 60th anniversary, the Foundation has launched a 2-year campaign which
  replaces last year's Project Generosity Challenge.
- · The Foundation asks Altrusans and friends to contribute at one or more of the six suggested giving levels:
- 1. \$60 (Light Blue)
- 2. \$160 (White)
- 3. \$260 (Teal)
- 4. \$560 (Dark Blue)
- 5. \$860 (Maroon)
- 6. \$1,060 (Gold)



- · All gifts will receive a special commemorative ribbon unique to each gift level.
- For all gifts since June 1, 2022, credit will be given to this campaign. Cumulative gifts, with the exception of Club 21, over \$500 USD made in each fiscal year will be eligible for Lamplighter recognition
- Each District will have a unique Mobile Cause fundraising page to share. For this giving campaign, we are
  asking that Districts create their own "challenge" among its membership to exceed last year's giving by 10%
  (Per District goal is \$12,000).

Contributions made between May 1, 2022-January 31, 2023 will be recognized with the color-matched ribbon at the District conference so that members may celebrate their support of this campaign. Recognition will also be given to 6 for 60 supporters at the International Convention for all cumulative gifts, except Club 21, made through May 31, 2023.

## The 6 for 60 Giving Campaign (cont.)

All contributions received across all programs from June 1-May 31 will be counted towards the Debby Weber Fundraising Awards.

#### The Debby Weber Fundraising Awards

- First place winners will receive \$1,500
- Second place will receive \$750
- Third place will receive \$500

The Debby Weber Fundraising Awards are named in honor of former International Foundation Trustee Debby Weber. The service awards will go to the winning Altrusa Clubs, and individual gifts count towards the club's total. The top three Altrusa Clubs with the largest fundraising gifts, and top three Altrusa Clubs with the largest gifts per capita, will receive the awards.

Contributions made between May 1, 2022-January 31, 2023 will be recognized with the color-matched ribbon at the District conference so that members may celebrate their support of this campaign. Recognition will also be given to 6 for 60 supporters at the International Convention for all cumulative gifts, except Club 21, made through May 31, 2023.

# Things to know about Club 21 Grants



- Grant awards \$2,500
- Additional can be awarded based on funds available
- One grant per fiscal year
- Key requirement: Health concerns of children and their families
- Altrusa clubs are ineligible to receive grants

# Disaster Relief Aid



### Things to know:

- District Governors may request relief for a non-profit in their area
- Club President may apply for a local disaster need
  - Club requests must be signed by the Club President and District Governor
- Foundation Chair approves grants from \$250 to \$2,500
- Requests above \$2,500 require approval from the Board of Trustees

# Altrusa Clubs Grant Program



### **PROJECT GRANTS**

- Literacy improvement, Days for Girls, Veterans Projects, Community Service Projects, Underserved Children & Adults
- Awards: \$250-\$4,000
- Hands-on service by Altrusans
- 2021-2022 Grants to Altrusa Clubs totaled \$268,511
- 2021-2022 District Five Grants awarded totaled \$20,616

# **Altrusa Clubs Grants Program**


### **Individual Grants**

- Grant Awards up to \$4,000
- To improve quality of life through continuing education in the field of literacy or vocational/technical training
- Grant can also fund a student from a developing country
- Newly chartered Altrusa Clubs are eligible for a one-time grant of \$2,500 to support a service project
- ASTRA Clubs may receive a one-time grant up to \$2,000 to begin service in their communities



Is your Club considering applying for a grant from the Altrusa International Foundation Inc. to aid an individual to improve her/his quality of life? Do you need a little help in making sure the individual meets the eligibility requirements for a Foundation grant? Having trouble getting started writing your grant application? If the answer to any of these questions is "yes," please read on for some tips that might help you.

#### **Individual Grant Guidelines**

Make sure your request is one that meets the eligibility requirements. The guidelines state that Altrusa Clubs may submit a grant request for an individual to improve the quality of her/his life through ordinued education either in the field of literacy or in vocational/ technical training. Individual Foundation grants might also fund a student from a developing country who needs financial assistance in completing her/his studies. An individual may not have received a previous grant from the Altrusa International Foundation.

- 2. Eligibility Requirements (5 points) All project grants must involve at least two of the following eligibility criteria
  - serving sick or disabled children, e.g., physical, neurological, sensory, cognitive
  - providing training in health and nutrition
  - providing an environment for sick or disabled children to work with camp activities/training
  - providing medicine and/or medical aid utilizing trained professionals
  - providing education to promote literacy and other areas of learning
  - benefitting underprivileged children requiring medical attention
- Need (10 points) Describe the country, state or community's need for the grant and how many participants will be served by the project.
- 4. Project Description (25 points) Describe the project in detail, including (a) target population, (b) objectives, (c)

# Secrets for Success

- Give yourself plenty of time; do not wait until the last minute to prepare the application.
- Complete in detail all the questions on the application
- Utilize a good proofreader.
- Triple check last-minute changes.
- Keep within the three-page limit for the narrative (Does Not include Budget and Budget Narrative).
- If you are overbooked, ask for help.
- Make sure that the budget adds up and balances.

# **Grant Writing Do's**

- Research and review the guidelines of the grant to ensure your project request aligns with the International Grant Committee's goals for giving
- Have your first draft completed well before the due date
- Make your proposal abstract short and to the point and include an overview of what you propose to do, with who, when, how and towards what measurable outcome
- If a project grant: Stress how your Club will be "on-hands" with completing the project
- When naming the grant request, be clear on the projects outcome so it will be hard for the reader to say no – ie: Essentials to Ensure Healthy Children
- Convince the Grant Committee that what you propose to do is important and that your organization is the right one to do it
- Include clear and concise measureables that will be part of the project ie: will conduct a pre-grant survey and a post survey that will be compared and used to measure impact

# **Grant Writing Don'ts**

- Don't ask for funding for anything outside the parameters of the grant
- Don't ask for more than the top funding level available
- Don't amble in detail or digress when describing your project
  - Be detailed, but concise
- Don't promise more than you can accomplish within the stated budget or allotted time frame

# STEPS TO FORM A LOCAL CLUB FOUNDATION UNDER THE INTERNATIONAL UMBRELLA



- Board of Directors and the Club must approve the formation of the Foundation
- Foundation approval should be clearly reflected in the minutes
- Obtain a new Federal ID number – IRS.GOV – Form SS4
- Submit the required documents to the International Foundation office

# Required documents to submit to International

- a) Articles of Incorporation
- b)Bylaws
- c) Minutes of the Board of Directors and minutes of the Club meeting evidencing approval of forming a Foundation
- d)Copy of Form SS-4, Application for Employer Identification number

### **FOUNDATION**



Open a separate checking account using your new federal ID number

- Foundation is a separate entity from your club
- Your Club should elect Foundation officers to serve on the Foundation Board
- Adopt a Conflict of Interest policy
- Separate records must be kept from the Club
- Your Club is what you do for YOU
- Your Foundation is what you do for OTHERS

- Once application with International is approved, you must register your Foundation with the Secretary of State, filing your Articles of Incorporation
- Do not register with the state prior to International's approval
- Annual LCF report due annually to Altrusa International Foundation
- Annual filing of the Federal Form 990 must be done
- Annual reporting to the state is required
